#### WEINGARTEN ERROR COST THE AGENCY

The Federal Labor Relations Authority (FLRA) denied the agency's exceptions to an arbitration award that reduced the grievant's 10-day suspension for various alleged infractions to an informal letter of warning.

The agency contended that the award was contrary to law because the arbitrator found that the agency violated the grievant's *Weingarten* rights despite the fact that the grievant was told that the meeting was for "safety concerns" and non-disciplinary. The FLRA stated that there were several factors that could have made the grievant fear discipline, supporting the arbitrator's conclusion that "the grievant felt threatened that discipline might be assessed at the meeting.

The agency suspended the grievant for 10 days on four charges. The stipulated issue at arbitration was whether the suspension was for just cause. The arbitrator determined that the agency violated the grievant's due-process rights: 1) the agency "didn't fairly or objectively investigate" the charge that was based on the grievant's allegedly unethical conversation with a contractor: 2) it refused to postpone a meeting between the grievant and upper-level supervisor until the grievant could obtain union representation, and in so doing violated the grievant's Weingarten right. Based on these agency missteps, the arbitrator concluded that the suspension wasn't for just cause. Finding the 10-day suspension excessive, the arbitrator ordered it replaced with an informal letter of warning.

The agency contended that the award was contrary to law because the arbitrator erroneously found that the agency violated the grievant's right to representation. The agency argued that the grievant could not reasonably have believed that discipline might result from the meeting, "because he was told that the meeting was for "Safety Concerns" and was non-disciplinary.

The FLRA stated that even assuming the agency told the grievant that the meeting was non-disciplinary, there were several factors that could have made the grievant fear discipline. These factors included: 1) the grievant's awareness of the agency's concern with his EEO activities; 2) the upper-level supervisor's visit to the grievant's worksite that day to discuss EEO policy; 3) the supervisor's specific reminder to the grievant about their meeting; and 4) the presence of three supervisors at the meeting, which surprised the grievant. Based on these factors, the arbitrator concluded that "there was no doubt that the grievant felt threatened that discipline might be assessed at the meeting."

The above scenario points out the fact - that the grievant, not the agency, is the one who determines if a meeting may lead to discipline. For further information pertaining to *Weingarten* rights, contact me.

#### ANSWERS FROM TEDDY THE TAX MAN

Q: I really, really am asking this for a friend. Her husband found out that in March, she changed her W-4 from claiming 0 allowances to claiming 9. In November, their tax advisor did a projection of the 2015 return, and it showed that instead of their 'normal' almost \$1,000 refund, they'd be owing approximately \$8,000. \$8,000!!! When the advisor did a separate filing for each of them, it showed that she'd be owing \$6,000 and he'd be getting a refund of less than \$200. How can that be possible?

A: There are many answers and/or possibilities to your situation. Uh, I mean, your friend's situation. Maybe all the children are being claimed on hubbub's return and not the wife's. Maybe there were educational credits that are allowed on the joint return and not on the separate returns. Maybe the alternative minimum tax is killing one or both spouses on the separate returns. I recommend that neither one of them claim 9 allowances in 2016. It's far too messy.

Q: I'm still going to call you so that you can help me roll over my TSP to an IRA. The reason I've been dragging my feet is that I can roll it over to my bank, or I can roll it over to my credit union. My cousin, whom I trust very much, said that for something like this, he didn't recommend either one of those entities. Although he explained and I understood, can I still hear YOUR thoughts?

A: Think about it. The institutions that you mentioned above, generally specialize in savings

accounts, checking accounts and loans. AND THEY ARE GOOD AT IT! For the most part, they don't specialize in IRA's and other investments. I'm guessing that if you're trying to build your retirement future, you probably want someone who knows retirements and does it for a living. He/she can tell you what you need to watch for, when to move and can offer so many other nuggets to you for your retirement success, that I think at some point, you'll say that it was worth it.

Q: Once my 401k is rolled over to an IRA, how long do I have to wait to take a distribution?

A: The IRS doesn't have a minimum amount of time that the funds must remain in the IRA before a distribution is taken. It's up to the company to which the funds are being moved. I recommend checking with the new company or the advisor who's helping you, so that you'll know in advance.
